

TERMS AND CONDITIONS

This "Spin the Wheel" contest ("Contest") is brought to you by Piaggio Vehicles Private Limited ("PVPL"). Please read these terms and conditions ("T&Cs") before entering the Contest. You agree that, by participating in this Contest, you will be bound by these T&Cs and you acknowledge and agree that you satisfy all Contest eligibility requirements as provided herein below.
